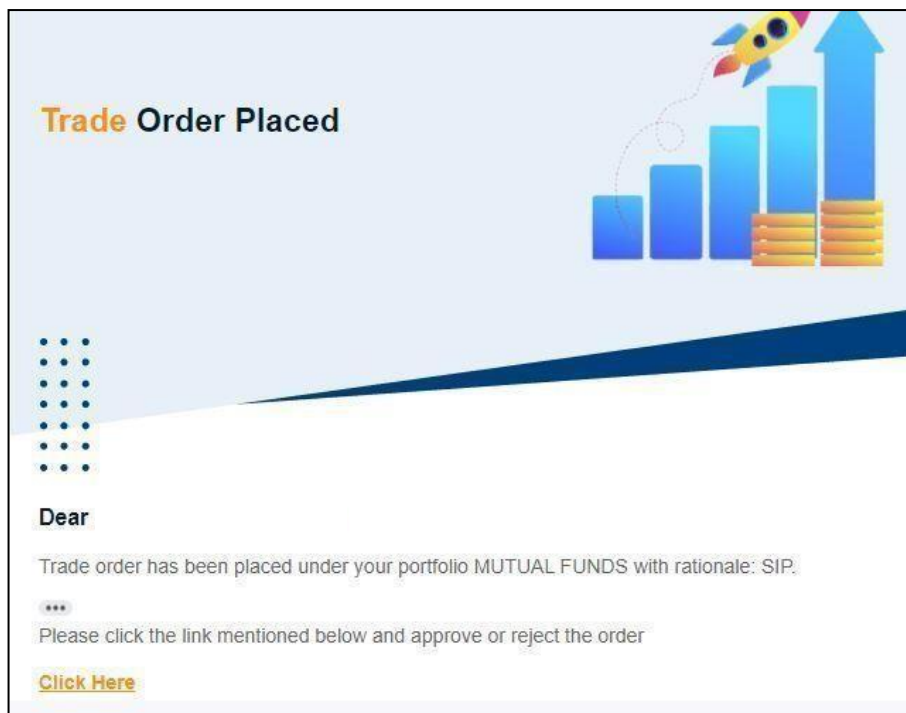



## NSE- Fresh Purchase Plus SIP Registration Process

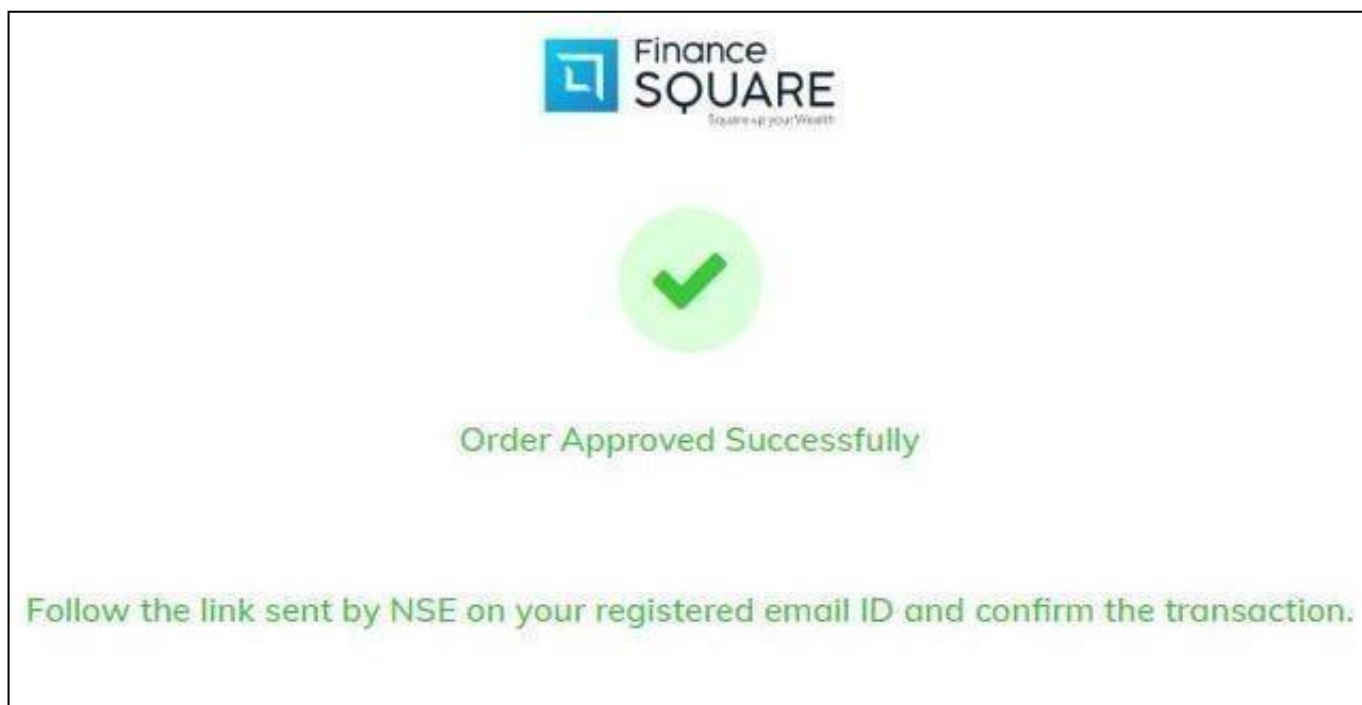
